

- 1.0 The name of the Company is RAFIKI TOURS & TRAVEL LIMITED.
- 2.0 The Registered office of the company will be situated in Zanzibar.
- 3.0 The objects for which the company is established are:-
 - 3.1 To carry on the business of tour operators, tour guides, hotels, bungalows, restaurant, inn, owner of motor vehicles, car hire and transporter of tourists, carrier by sea, land, air, charter flights and by any means of transportation.
 - 3.2 To carry on the business of travel agents and or/contractors, and to promote and facilitate travelling, and to provide services and facilities for tourists, travelers and sailor, to provide bookings for travelling, ticket, accommodation, lodgings, group parties, to provides tour guides and travel information.
 - 3.3 To present a presentable picture of Zanzibar to foreign tour operators and travel agents who intend to bring tourists to these Spice Islands.
 - 3.4 To undertake all such other things as are or any be deemed incidental or conductive to the company.
 - 3.5 To establish and carry on either jointly or as a distinct and separate business, the business of courier services, shop and complexes with supportive infrastructures and activities.
 - 3.6 Subject to shareholders agreement on the objects and capital of the Company, to adopt and carry into effect either with or without modification all those agreement entered into between the promoters of the Company in connection with various undertakings of the company.
 - 3.7 To carry on the business of general traders and in particular to carry on the business of importers, exporters, store keepers, commission agents, buyers, sellers and dealers in goods, stores and consumables of all kinds both wholesale and retail and in that regard to establish supermarkets and do any other business that may be carried on in that connection.

21.0 ADDITIONS AND ALTERATIONS:

Subject to the provisions of the Companies Decree and to those contained in the Memorandum of Association, the Company by a special Resolution, may make alteration or additions to these Articles of Association and any such alteration so made shall be valid and effectual as if originally contained in these Articles and be subject in like manner to alteration by special Resolution.
