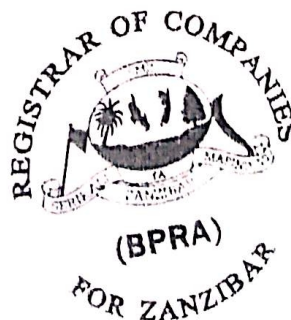

**NOUR AL-MUSTAFA ZANZIBAR COMPANY LTD**

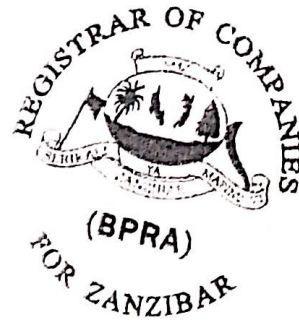
1. The name of the Company is **NOUR AL- MUSTAFA ZANZIBAR COMPANY LIMITED.**
