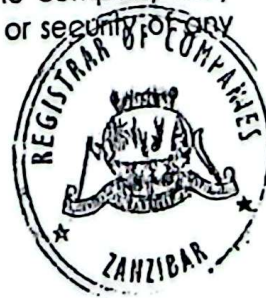

1. The name of the Company shall be "FAIR AFRICA TOURS & SAFARIS LIMITED".
2. The registered Office of the Company will be situated at KWA MCHINA in Zanzibar.
3. The objectives for which the Company is formed are:-
 - (a) To carry on business of tour and tourist agent's, air tickets, Transportations, Organize Holiday Trips ,Package Trips and to provide business as a Tour operators ,Travel agents and to promote Concept of Time Share to provide accommodation in the luxury hotels and resorts and also to provide earning opportunities in the field of tours and travels promoting through referrals like our tour packages which may be Pilgrimage , Business ,Educational, Leisure, and Picnic purposes, hiring out boats, and to provide such other services to Local, National and International Tourists.
 - (b) To represent, Organize, Guide arrange and act as Tourist Agents, Vehicle Booking Agents and Reserving or Booking Accommodations, Seats, Compartments, Hotels Booking Agents, Ticket Booking Agents, Parcel and Postage Booking Agents, Telephone Booth Operators and to provide necessary services for Obtaining Passport and Visa and to Assist in providing Banking facilities to Tourists and also to handle conferences and meetings in India and abroad;
 - (c) To keep up and furnish any property for the purpose of letting the same to visitors or guests whether in single room, suites, cottages or otherwise;
 - (d) To carry out the business of management and running of hotels, guesthouses, lodges, apartments, bars and restaurants, letting

rooms, planning, financing, establishing, construction, coffee shop and all other hotel and tourist related activities;

- (e) To acquire, construct, maintain, improve, develop, work control and manage hotels, inns, motels, parlours, game lodges, restaurant, cares, tented camps, holiday camps, and other related undertakings;
- (f) To enter into any arrangements and contracts with Governments, Supreme Authorities, municipal, local or otherwise or any corporations, companies, or persons having objects that may seem conducive to the company's objects with any of them and to obtain from any such Government Authority, Corporation, Company, or persons any characters, contracts, decrees, rights, privileges and concessions;
- (g) To borrow or raise or secure the payment of money in such manner as the company shall think fit, and in particular by the issue of debenture stock, certificates of other securities, perpetual or otherwise charged upon all or any other company's rights and property (Present and future) purchase, redeem or pay off any security or loan;
- (h) To amalgamate with or enter into partnership or into any arrangement for sharing profits, union of interest, cooperation, joint venture, reciprocal concession or otherwise with any person or company carrying on or engaging in or amount to carry on or engage in any business or transaction which the company is authorised to carry or engage in any business or transaction capable of being conducted so directly or indirectly to benefit this company. And to take or otherwise acquire shares and securities of any such company, and sell hold re-issue with or without guarantee, or otherwise deal with the same;
- (i) To promote another company for the purpose of acquiring all or any of the property and liabilities of this Company, or for any other purpose, which may seem directly or indirectly calculated to benefit this company;
- (j) To sell or dispose of the undertaking and property of the company or any part thereof, for such consideration as the company may think fit, and in particular for shares, debentures, or security of any
