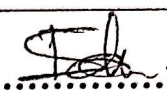
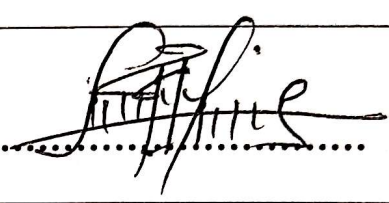
MEMORANDUM OF ASSOCIATION

OF

KOLEKOLE TOURS ZANZIBAR AND SAFARIS LIMITED

1. The name of the Company is **KOLEKOLE TOURS ZANZIBAR AND SAFARIS LIMITED**.
2. The Registered office of the company will be situated in Zanzibar.
3. The objects for which the company is established are:
 - (a) To carry on business of tourism and management of shore side and sea side hotel village facilities, and carry on business of arranging and conducting hotel reservations, marine sports activities, game fishing and all other marine activities.
 - (b) To carry on the business of tour guide in excursions and travels in accordance to tourism existing laws in Zanzibar and Tanzania mainland, tourists transfers and walking with tame animals, operators, agents of tour operators, travel agents, owners of motor vehicles, motor-car hirers and transporters, and all tourist and travel related services eg, seaports, fishing, sports, ticketing, tour operations.
 - (c) To carry on the business of tour operators, proprietors and owners of aircrafts and ships, charters and agents for operators of air, sea, land and inland waterways, road transport owners and rent and hirers of motor vehicles of all kinds and other vehicle for water sports.
 - (d) To carry on business of arrangement of various trips for foreign and local tourists such as diving and cruising; giving diving and swimming courses, charter of boats, line-fishing, deep-sea fishing, game fishing, also to deal with water sports of all kinds, scuba diving, snorkeling, goggling, sailing, water skirling and wind surfing. And to do all other activities relating to Sea/sunset cruise, natural sea water and lagoon tour, under-water photography and all other activities allied to tourism business.
 - (e) To engage in the business of agent and coordinate ferry charter in a way of ferrying tourists including island ferry to see Dolphin.

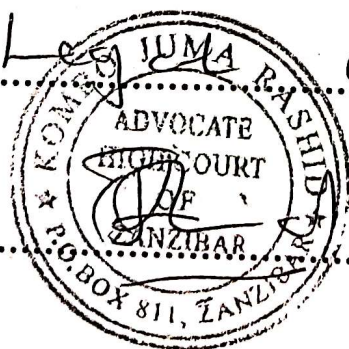
